


OFFICE ORDER

The Vice Chancellor is pleased to allot the University Residential Accommodation No. E-3 to Dr.(Mrs.) Manju Baghmar, Asso. Prof., Bus.Adm., U.C.C.M.S. (on leave), Ex Warden, Gargi Girls Hostel.

She should submit the consent of occupying the allotted quarter along with following undertakings on Non Judicial Stamp Rs.100/- with in 7 days of the receipt of the order:-

- (i) That she do not have own house in the town in his name or in the name of her spouse or dependent children as per the rule No. 2 (iii) of the Rules of Residential accommodation
- (ii) That she shall abide by the rules framed/modified or orders/instructions issued in this behalf for residential accommodation from time to time by the University.
- (iii) That she shall be liable to the payment of rent as per rules.
- (iv) That she shall be liable to the payment of Electricity & Water Charges & she will be responsible for enhanced charges and delayed payment.

She should shift in the quarter within 30 days otherwise as per rule No. 7(i) of the Rules of Residential accommodation the order will stand cancelled. The rent shall be recovered by the respective authority from the salary bill of every month in accordance with the university rules in force time to time.
