Minutes of Meeting

A meeting was held under the chairmanship of Shri Nihal Chand Goel, Additional Chief Secretary, Forest & Environment on 02.03.2017 to discuss the issue of tree cutting permission for Tonk-Sawai Madhopur section of NH-116. The list of participants is enclosed at Annexure-1.

Chairman reviewed the compliance status of decisions taken in the meeting held on 27.01.2017 on this matter. CGM, NHAI informed that they have submitted the representation as directed in the matter vide their letter dated 30.01.2017. The joint inspection of trees with Forest Department for enumeration of trees and affected area has already been done.

After deliberations, following decisions were taken:

1. As per joint verification, in Tonk district the number of trees which are required to be felled is 1386, existing in 6.26 ha area. The strip chart for the area calculation and enumeration of trees was provided to DCF, Tonk. It was agreed that DCF, Tonk will provide the revised demand note for the 1386 trees and double the cost of NFL on affected area of 6.26 ha by 03.03.2017 and NHAI will deposit the amount as per demand note by 04.03.2017, whereafter tree cutting permission will be issued by DCF, Tonk. Thereafter NHAI will cut the trees and deposit them in the stock yard/depot notified by DCF, Tonk.
2. As per verification, in Sawai Madhopur district the number of trees which are required to be felled is 136, in an area of 0.15 ha. The strip chart for the area calculation and enumeration of trees was provided to DCF, Sawai Madhopur. It was agreed that DCF, Sawai Madhopur will provide the revised demand note for the 136 trees and double the cost of NFL on affected area of 0.15 ha by 03.03.2017 and NHAI will deposit the amount as per demand note by 04.03.2017, whereafter tree cutting permission will be

issued by DCF, Sawai Madhopur. Thereafter NHAI will cut the trees and deposit them in the stock yard/depot notified by DCF, Sawai Madhopur.

3. NHAI will also request on 02.03.2017 itself for issue of revised demand note to DCF Tonk and Sawai Madhopur, mentioning the requirement of trees to be felled and area affected as per their requirement.

Meeting ended with a vote of thanks to the chair.
